- 2. **Minutes of Previous Meeting.** Were read and deemed accurate/ Proposed by Karen Shaw and seconded by Brian Turnbull.
- 3. **Matters Arising** Lila thanked Karen for agreeing to go the Network meeting in London with Rosemarie on 1st May. She also asked that a get –well card be sent to Des. Lila reported that she has had correspondence from Sam Mauger re "Keeping it Legal" workshops and from Sophie Wellings re follow-up to the Volunteer workshops held last year. Marjorie Ringland (Treasurer) confirmed by email that there were no transactions since the last meeting.
- 4. **Trustee Report** is attached but in brief, Rosemarie reported that she had attended NEC meetings: plans for an EGM in Birmingham on 21st March are progressing, and that a workshop on "Keeping it Legal" will be held in Belfast on 23rd April (TBC). Sophie Wellings will provide details of forthcoming workshops for those interested in assisting the Regional Trustee and Regional Volunteer hopefully in April. Rosemarie also informed us that a proposal at the forthcoming EGM is that the Regional Trustee tenure may be extended for a maximum of a further 2 years, if the Trustee so wishes.
